Caracal and Cezienne, Oltania, Sponsorship For



C.A.S.T. currently supports two adult institutions in Oltania; one in the small town of Caracal and one in the village of Cezienne. As with many of the large institutions across Romania, both institutions are placed in remote rural areas about an hour away from the nearest large town; Slatina, one of the largest towns in the region of Oltania. Both institutions are similar in size, with around 80 people living in each, with all residents aged 18 years or above. All of the people living in the institutions display a wide range of physical disabilities, along with developmental delays in a number of areas (i.e. motor, sensory, cognitive) and general learning/psychological difficulties.



Some of the residents are relatively able and may only show developmental delays in terms of speech or general cognitive ability but are physically able. However, many of the residents have been much more severely affected by their deprived background, resulting in them experiencing problems both physically and mentally. This may be displayed as their being unable to communicate verbally, or even, the ability to move themselves.

The people living in the adult institutions at Caracal and Cezienne are living in state care, generally due to their having no family to care for them, or their family being unable to care for their specific needs. Your sponsorship will make a huge difference to the people living at Caracal and Cezienne along with people living in the local communities.

Here are some ideas of how your money could help:

£5 could buy soap, a toothbrush each and toothpaste for ten adults

£5 could fund a beneficiary's food throughout a specialist summer camp

£20 could provide an adult resident with winter clothing suitable for the extremely low temperatures experienced during Romanian Winters.
